3. MEMORIALS OR CONDOLENCES

Cr Denise Sims expressed her sincere condolences on behalf of Council at the passing of the late **Mr Eric Dohle** who passed away unexpectedly on Wednesday, 27 December aged 75.

Cr Sims noted that Mr Dohle had worked for the Australian Paper Mill for much of his life and held a special place in the hearts of the locals in Moreton Bay, and was a prominent member in our community, and a fount of knowledge connected to the history of our area. The Dohle family moved to Dohles Rocks in the early 1900s where Eric's family established a boat-building business. Mr Dohle was also instrumental in lobbying the then Pine Rivers Shire Council of the need to establish a museum in the local area, which resulted in the inception of the Pine Rivers Heritage Museum. He was also a member of the North Pine Historical Society and the ANZAC Memorial Avenue Centenary Committee.

Cr Sims noted that Mr Dohle would be sadly missed and not forgotten for his contributions to the local area and conveyed her sincerest sympathy to his wife, Judy and family.

5.1. **Petition - Request to consider an upgrade of three major creek crossings on McNamara Road, Rocksberg 4510**

Cr Adrian Raedel tabled a petition containing 99 signatures, received from Diana and James Caldwell, reading as follows:

We the undersigned residents of Moreton Regional Council, request that Council:

"The residents residing on Upper Caboolture River Road that then becomes McNamarra [sic] Road, Rocksberg request the Moreton Bay Regional Council consider an upgrade of three major creek crossings on McNamarra [sic] Road, Rocksberg 4510.

The creeks being Eliza Creek, Cockies Crossing and Five Pound Crossing.

Residents are affected when there are both major and localised rainfall with access to residents leaving or returning to work/home/school during these times.

There are a number of residents that have lived in the area for many years and have been affected on numerous occasions when these creeks flood and whilst residents understand that it is not economical to flood proof during time of major localised flooding there are numerous occasions where access is cut off during times of minor flooding, one such recent occasion being Wednesday 27th November 2017.

There has also been occasions where residents are trapped between two crossings for a number of hours before the creeks reside enough to allow access to either Morayfield or their properties.

The residents respectfully ask the Moreton Bay Regional Council to assess these creeks with either the addition of more or larger pipes, raise the level of roads and install guard rails as a safety precaution and regular cleans of the pipes of foreign debris ie trees and branches to allow the creeks to flow."

It was resolved:

1. **That the petition regarding a request to consider an upgrade of three major creek crossings on McNamara road, Rocksberg, be received.**
2. **That the matters raised be referred to Director Engineering Construction and Maintenance for investigation and report to Council, if required.**
3. **That the Principal Petitioner be advised accordingly and forwarded a copy of the petition.**
4. **That the Principal Petitioner and Divisional Councillor be kept informed of any action taken in relation to this petition.**
