MEMORIALS OR CONDOLENCES 3.

The Mayor, Cr Allan Sutherland made mention of the late Mr James (Jim) Bernard George who passed away at the age of 89. The Mayor advised that Mr George was a local identity of the Redcliffe peninsula having been a builder and boat builder and who was well known for his contributions to the community. The Mayor also noted that Mr George held the number 1 membership of the Moreton Bay Boat Club and established the first rescue organisation way before any other rescue organisations were up and running.

The Mayor also noted the late Mr Neville (Nev) John Pask who passed away at the age of 89. Mr Pask was a property developer having established his family business on the Redcliffe Peninsula in the 1960's, with one of his earliest developments being the Daltons Estate behind the Redcliffe Hospital. The Mayor noted that Mr Pask was a very generous man throughout the State of Queensland. Cr James Houghton also noted that Mr Pask was a patron of the PCYC.

Cr Adam Hain made a special mention of the passing of his uncle, Mr Roly a resident of Dayboro who passed away tragically from a farming accident.

Councillors observed a moment's silence in memory of residents who had passed away, noting Council's sympathy.
