"Do not remove any headstones from the lawn section Tallowwood Cemetery, Tallowwood Drive, Deception Bay. Stop the proposed work to be carried out at the cemetery until there has been consultation with people that will be affected by this works project and seek a nother [sic] alternative solution to the issues in the cemetery".
