5. PRESENTATION OF PETITIONS

(Addressed to the Council and tabled by Councillors)

Petition - Off-leash dog area, North Queens Beach, Scarborough (A16794904)

Cr James Houghton tabled a petition containing 34 signatures, received from Patricia Seymour, reading as

We the undersigned residents of Moreton Bay Regional Council, request that Council:

"Unfortunately, most dog owners congregate at a dangerous area of North Queens Beach at bottom of pedestrian hill where cyclists and runners come down at speed. The southern end of North Queens Beach is more appropriate for unleashed dogs as a large bank of rocks helps contain them The dogs are mainly 'off leash' to and from vehicles. Surely residents, particularly elderly, need to walk before 8.00am and after 4.00pm in the summer months. I walk in the sand for health reasons, particularly feet, and I fail to understand why prime times are allocated to dogs. Surely this is discriminatory to residents and there could be a window of time before 7.00am that could be allocated to residents. Unfortunately not all dog owners are responsible and Sunday, 25 March, a large white Alsatian jumped up on me, only grazed my arm but a frightening experience for me. The beach has now become a 'walk at your own risk'. In August 2017 a small white dog was killed by a larger 'off leash' dog. Not a nice experience to be witnessed at the beach. We do not think we are asking too much of Council to be able to walk on the beach in peace at cool times of the day without fear of being attacked. Unfortunately the original signage advising proposed 'off leash' area was ambiguous."

It was resolved:

- 1. That the petition regarding off-leash dog area, North Queens Beach, Scarborough, be received.
- That the matters raised be referred to Director Community & Environmental Services for 2. investigation and report to Council, if required.
- 3. That the Principal Petitioner be advised accordingly and forwarded a copy of the petition.
- 4. That the Principal Petitioner and Divisional Councillor be kept informed of any action taken in relation to this petition.

Cr Mike Charlton (Deputy Mayor) opened the Community Comment session, making the required statement regarding the conduct of the Session, and invited Mr Michael Iacovella to address Council.

7.1. Mr Michael Iacovella - 80 Plucks Road, Arana Hills, QLD, Development

As part of the Community Comment session, Mr Michael Iacovella, addressed the Council in respect of the 80 Plucks Road, Arana Hills development proposal and spoke on behalf of the residents of the community who lodged an objection and raised the following points:

 The revised proposal of 80 Plucks Road, Arana Hills, has removed the access point at Leatherwood Drive, and now includes only one access point at Plucks Road.

This was a cause of concern and suggested that at least two access points would be needed at the development site, at both Plucks Road and Leatherwood Drive, in order to spread traffic load.

At a meeting between residents and Mirvac, it was indicated that the change from two to only one access point was a requirement of Council based on community objections.

The impact on a Plucks Road only access point will place more pressure on existing traffic volumes, especially during peak times.

- The current road markings are inadequate and suggests to extend the 50km limit beyond the development site and ending at the South Pine Road turnoff.
- Suggests to extend the proposed right-turn lane to be extended to include the three properties leading up to 80 Plucks Road as they all have driveway access onto Plucks Road.
- There was a lack of consultation between the developer and residents which has created distrust, which extends to the Council process. Suggests strong leadership with active engagement to bring the developer and residents together.
- Suggests the current process needs to change to avoid anger, frustration and distrust felt by
 residents, to find a better way to engage the community with projects similar to 80 Plucks Road
 which would have a major impact on landscape, environment, infrastructure and road safety.
