## 7.1. Ms Helen Juillerat - Illegal dumping on Nicol Way, Brendale:

As part of the Community Comment session, Ms Helen Juillerat, addressed the Council in respect of illegal dumping in Nicol Way, Brendale and raised the following points:

- Illegal dumping on Nicol Way, Brendale has been a problem for many years and Ms Juillerat has become involved since her retirement during the past year.
  - She has lodged 16 reports of illegal dumping to Council since the beginning of 2018 and feels that Council are not fixing the problem.
- Mr Jullierat had been advised that a CCTV camera was mounted in January 2018. She subsequently
  contacted Cr Mike Charlton and received a response, however she believes that the CCTV camera
  on the corner of Hall and Station Streets, Strathpine is insufficient.
- Ms Juillerat and other residents are annoyed with the illegal dumping and cannot locate the CCTV camera.
- Suggests an 'illegal dumping' sign to be erected at the end of Nicol Way, near the railway line.
