Cr James Houghton referred to the recent passing of the late Mr Ken McCrohon a former Australian Rugby League player and the first coach of the Redcliffe Dolphins BRL side. Cr Houghton stated Mr McCrohon had been a pleasure to know and recalled playing a number of games of rugby league with him. Mr McCrohon was a great asset to the Redcliffe Dolphins Club and would be sadly missed.

Cr Adam Hain mentioned the passing of the late Mr James "Jim" Cassimatis who had owned and operated newsagency businesses in North Lakes and Caboolture. Mr Cassimatis genuinely cared about the Caboolture CBD and was a great advocate for change in the region.

Cr Adrian Raedel concurred with Cr Hain's comments stating that Mr Cassimatis had been a very active member of the former CBD Traders group and was passionate about business in the area.

Cr Matt Constance sadly reported the sudden passing of the late Mr Aldo Tumini the founder of Aldos Barbershop at Mitchelton. Established in 1971, the barber shop was a very well-known and extremely busy business. Mr Tumini had a reputation for mentoring and developing young apprentices, and in recent years had sold the business to a former apprentice. Despite having sold the business, Mr Tumini would still attend the shop on a regular basis to cut hair.
