3. MEMORIALS OR CONDOLENCES

Cr Mick Gillam made special mention of the late **Mr John Leonard O'Brien**, also known as 'JL', who passed away on 14 November 2018. Mr O'Brien was born in 1933 and after attending Rosalie Marist Brothers School, was briefly in the Australian Air Force, then joined Colgate Palmolive as a forklift driver where he worked his way up to State Sales Manager - a position he held until his retirement.

Mr O'Brien and his family lived in Lawnton and later Bray Park where he was instrumental in the push to build the Holy Spirit Parish Church, which he was actively involved with up until his passing. Mr O'Brien played rugby league for Normanby and Wests in the Brisbane competition until 1964 and as a keen lawn bowler joined the Pine Rivers Memorial Bowls Club in 1976. He was involved in the construction of the Club's first clubhouse and its subsequent move to the present site on Francis Road, Bray Park. Mr O'Brien was a member of the Club for 42 years, serving as President in 1988 and from 1993-1995, and he was also made a Life Member.

Cr Gillam conveyed condolences to Mr O'Brien's family noting that he will be missed by the Club and community.
