Conditions:

All applications for waste disposal authorities must be made in writing by the resident or organisation eligible for a Waste Disposal Authority as detailed in Council's Policy: 2150-042 - Disposal of Waste Free of Charge Policy at City of Moreton Bay's Waste Management Facilities for eligible Residents, Ratepayers, Community Groups and Charities

- All applications will be assessed and may be declined at Council's discretion. Applications will be assessed within 10 business days of being received by Council.
- Waste disposal authorities are not available for disposing of commercial/business waste, regulated/hazardous waste or where the waste is collected and transported on behalf of a resident for fee and reward (i.e. the person or organisation engaged to deliver the waste on behalf of a resident charges or receives a reward for the service).
- If the waste transporter is not able to present the required identification matching the details listed on a waste disposal authority, the waste disposal will be charged in accordance with Council's fees and charges.
- Domestic general waste means waste resulting from the ordinary domestic use or occupation of a house, flat, apartment or unit. Domestic waste may also be referred to as Municipal Solid Waste (MSW) or household waste. In practice, domestic general waste includes the material that householders place in the general waste bins or the mixed waste self-delivered to Waste Management Facilities and Transfer Stations from their own residential dwellings.
- Vehicle delivering waste must not exceed 4.5 tonne gross weight or fees and charges may apply.

Queensland's Waste Levy - Council Responsibility

Landfill operators must collect a waste levy for all waste disposed to landfill on behalf of the Queensland Government. All waste disposed to landfills attracts the waste levy unless specifically exempt. The purpose of the Waste Levy is to minimise waste being sent to landfills and divert recoverable items for reuse, reprocessing into new products and recycling.

Queensland's Waste Levy Landfill customer, including residents, responsibility.

(Waste Reduction and Recycling Act 2011)

The person delivering waste to the waste disposal site must give the operator of the waste disposal site the information required to identify -

- (a) how much of the waste is exempt waste and how much of it is levyable waste; and
- (b) for each type of waste required to be measured by the operator under section 59-how much waste there is; and
- (c) whether the waste was generated in the waste levy zone, the non-levy zone or outside Queensland.

Maximum penalty—300 penalty units (\$46,440 based on penalty unit current at 1 July 2023)
